The Texas Board of Pardons and Paroles Division Granted Your Parole.
You were given an FI-5R

Dear Mr. ██████████ :

It gives me great pleasure to say "You are coming home." We have been monitoring your file following the voting process and were just informed that you received an FI-5R. I apologize for not sending you a summary of the arguments I presented to the parole board at the parole board appearance when I argued for your release. Before I could dictate that letter and send it to you I received a call from the parole board indicating they had agreed with my arguments and granted you parole. I argued for your release on June 17, 2015 and I was notified of your release on June 18, 2015. In the 25 years I have been representing inmates before the parole board this is the fastest decision I have ever received. Congratulations you are going home!

FI-5 Transfer to Inpatient Therapeutic Community Program. Release to aftercare component only after completion of IPTC program.

Do not mess up. Do not receive any disciplinary actions. This is the chance you have been waiting for, so please, do not do anything which could cause you to lose it.

██████████, it is very difficult to convince the Board to release an inmate these days on a 15 year sentence for retaliation on a police officer. The percentage rate for release is less than 15% for the type of crimes you have been charged with this type of charge. Most inmates have to serve their entire sentence or at least 80% to 90% before they receive parole, but we were able to convince the Parole Board to grant your

release. Someone with the type of charges you are incarcerated for rarely receive release. Continue with a good attitude and keep in mind that your reward will be release to parole. I was able to prove to the Parole Board that you are one of those inmates who deserves such a vote. You must not make a mistake and receive a disciplinary case.

Upon release to parole, I stress, be very careful. You must be a model citizen and parolee. Abide by all of the stipulations and requirements placed upon you. Should you not follow the requirements and stipulations exactly, you are asking to be sent back to prison and if that should occur, the chances of you being re-released are very slim.

I want you to take these next few months and plan out your future without a life of destruction. New charges can easily be picked up when you are labeled with a TDCJ number. You need to do your best to make the right decisions and surround yourself with the right people. You have a lot to look forward to when you come home and I am sure your family is more than ready for your return.

My staff and I worked very hard putting together your parole package and representing you. We would like the opportunity to meet you. Please come by the office once you are released or telephone me when you are released. I would like to go over your parole requirements and stipulations with you so that I know you understand everything that is going to be required of you. The last thing I want is for a client to be returned to prison because he/she was unaware or did not understand his/her requirements and/or stipulations.

Thank you for allowing me the opportunity to assist you with receiving your parole. The very best of luck to you. If I can be of any further assistance to you or should you have any questions, please do not hesitate to contact me. Also, if I can help any of your friends, please have them contact me. (I have enclosed some of my business cards.) Remember, very few inmates are released to parole.
